Exhibitors can move in through the side doors to the West Hall F ballroom via the loading lane and ballroom dock area accessed off Exhibit Drive on the far west/northwest side of the building, or hand-carry / roll-in booths through West Hall pre-function main entry doors, located in the front of the building using the drop-off lanes. In both cases, exhibitors are expected to transfer materials to the hall as quickly as possible, and then immediately move and park any vehicles before returning to the hall to complete setup. We do NOT recommend parking in the lot first and rolling/carrying items through the concourse, as the walking distance from the parking lot entrance to Hall F is far.

The main parking lot is behind the building. There will be a shuttle running back and forth between the parking lot and event entry doors, so if you are not in a rush, we would suggest waiting for the shuttle at the front of the parking area to take you back to the event entrance.
